# Design Features

A simple, honest material palette of concrete, glass, and masonry encloses airy volumes of flexible space, while a central atrium floods the interior with natural light, bringing the outside in. Vertical ribbons of wood and metal articulate the exterior in a brise soliel, diffusing the harsh Texas sun and broadcasting a soft glow throughout the space.






